La Canaria Hotel Operation with good results

May was a good month with an occupation of 70.2 %. So far this year La Canaria Hotel Operation (LCHO) has an occupancy of 83 %. We are able to get higher rates and still keep the occupancy on the same level as last year.

The high rates give us an increase in revenue of 6.2 % compared to last year. The cluster organization and cooperation with Mogan have also contributed with savings in payroll cost.

Net Operating Profit is 555,000€ by the month of May, which is 7,7% ahead of budget and 34% better than last year.

- When checking booking.com we can see that we are selling our hotel with around twice the rates as they ask for at the new hotel in Mogan for the summer season. This is very satisfactory, and gives us a feeling of confidence that our hotel is "one of a kind", says General Manager Finn Berstad. We have now experienced that the new hotel in Mogan is not taking away the clients from our hotel.

Our hotel is keeping its position as one of the best hotels on the island, and we have a rating of 9,1 in booking.com - which is recognized as a "Superb Hotel".

We trust that Radisson Blu are doing their utmost to continue selling our hotel as a first class hotel, and that they will manage to keep our premium position also in the future.

The General Manager, Finn Berstad, also says that reservations look good for the rest of the year.

On June 1st it was 5 years since Radisson Blu Resort, Gran Canaria opened. **This was celebrated during the owners cocktail** on June 1st with a 5 candles birthday cake.



The Costas concession

The Costas' announcement to the public in newspapers about our application for concession is mandatory. The official date for closing the public information and the deadline for objections was May 25th. **There has not been any particular allegations against the concession.**

We have information that Costas Las Palmas is now preparing a proposal to Costas Madrid to offer a concession to us.
